## MINUTES OF THE PPG MEETING HELD ON TUESDAY 21<sup>ST</sup> MARCH AT SEAHOUSES HEALTH CENTRE

1. Sharon Spurling of Carers Northumberland came to talk to the PPG. Their remit is to support the unpaid Carers, whether that be family, friends, neighbours or anyone who cares for someone else. They have at the moment 7 staff and 25 volunteers and have bases in Hexham, Ashington and Belford at Bell View. In 2011 there were 36,500 carers in Northumberland who "care" for people more than 20 hours a week. 9,000 carers "care" more than 60 hours a week. They aim to promote opportunities outside of being a carer e.g. hobbies etc. They give advice about housing, finances, etc. They also try to give people a break from caring and run support groups around the county. Their advice and information line has over 100 calls every week. Carers can also access the Carers Support Fund which can give carers up to £100 to spend on themselves. They are trying to get specialist support groups to work with young carers. At the moment there are approximately 2,600 young carers in the county that are known to the service but there could be many more. They are working with schools to try and identify young carers

47% of registered carers are male. They are holding events around the county specifically aimed at carers, the first one is at Alnwick Gardens pavilion on 22<sup>nd</sup> May. They also run courses for carers.

The PPG thanked Sharon for a very interesting talk and hoped she would return in the future to keep us updated on the progress they are hoping to make in this area.
